

Federal Litigation on ACA's Requirement to Cover Preventive Services

May 2023 Update

On May 15, the U.S. Court of Appeals for the Fifth Circuit issued a ruling that stays (pauses) the lower court's ruling in Braidwood Management, Inc. v. Becerra ("Braidwood"), regarding group health plan coverage of preventive services. The stay means the ACA requirement that plans cover USPSTF-recommended items and services (with an A or B rating) is in effect until the Fifth Circuit rules on the merits of the case. We believe parties will be asked to submit briefs to the court this summer, which will be followed by oral arguments before a decision is issued. We will continue to monitor the case for updates and provide any additional information as it becomes available.



Federal Litigation on ACA's Requirement to Cover Preventive Services April 2023 Update

On March 30, 2023, the judge in this case issued his long-awaited remedy order in Braidwood Mgmt. Inc. v. Becerra, on the appropriate remedy for his September 7, 2022 opinion, finding that the U.S. Preventive Services Task Force (USPSTF) experts' appointments violated the Constitution's Appointments Clause. The court vacated all actions of the U.S. Departments of Health and Human Services, Labor, and Treasury (the "tri-agencies") implementing and enforcing the Affordable Care Act's (ACA) requirement to cover without cost-sharing USPSTF preventive services with "A" or "B" ratings. The order also enjoined enforcement of those requirements in the future. The court also found that the PrEP (a medication taken to prevent HIV contraction) mandate violates the plaintiffs' rights under the Religious Freedom Restoration Act (RFRA) and stopped the tri-agencies from enforcing the PrEP mandate against the plaintiffs.

Federal Litigation on ACA's Requirement to Cover Preventive Services

On September 7, 2022, a federal district court judge in Texas issued a ruling that calls into question the requirement in the Affordable Care Act for plan sponsors to provide preventive services at no cost to plan enrollees. The judge found that members of one of the agencies making coverage recommendations, the U.S. Preventive Services Task Force (USPSTF), were not lawfully appointed under the Constitution because they do not require Senate confirmation. In addition, he held that requiring the plaintiff in this case to pay for HIV prevention violates their religious freedom.

This ruling may allow but not require plan sponsors, including employers and plans selling on the Marketplaces, to adjust coverage of these preventive services and impose cost sharing and/or apply deductibles. At this point, it is unclear what the next steps are, since the judge in this case has decided to wait to issue another ruling on what the remedies for these plaintiffs are and how the decision may apply nationwide

Depending on what the judge says regarding Overall, there is concern that a patchwork of Depending on what the judge says regarding remedies, payers and plan soporsors may now have to decide whether to keep first-dollar coverage for HIV prevention and for the \$2 preventive services recommended by the USEIT, or else impose deductibles and copays for at least some of those deductibles and copays for at least some of those services. Services recommended by that agency include screening tests for breast cancer, colorectal cancer and lung cancer, sexually transmitted infections, diabetes, and depression. Overall, there is concern that a pactowork of preventive services coverage will cause confusion among both providers and patients and cause the overall system to lose some of the gains made over the past few years in ensuring more people have access to and use preventive care. Plan Sponsor Implications


Although the court held that the USPSTF's appointments violated the Constitution, Congress essentially adopted the USPSTF's recommendations that were in effect when it passed the ACA on March 23, 2010. Thus, it appears that the court's ruling only affects USPSTF recommendations made or updated on or after March 23. 2010, and therefore, plan sponsors are still required to cover as ACA preventive services USPSTF recommendations that were in effect prior March 23, 2010.

Both parties in the lawsuit can appeal the decision to the 5th Circuit within 60 days. We expect that the tri-agencies will ask for a stay of the decision pending appeal. In the short term, the court's ruling appears unlikely to have an immediate impact on most plan sponsors. However, if the decision remains intact, plan sponsors could have significantly more flexibility in the manner in which they cover certain preventive services going forward. absent congressional action to the

National Alliance Survey Reveals Plan Sponsor Implications

Given the recent ruling by a federal judge in Texas invalidating much of the Affordable Care Act's coverage of preventive care without cost sharing, 72% expect to continue providing coverage for all preventive services at 100%; 6% expect to be more selective; and 22% did not know how they would approach coverage for preventive care services
